Remarks: Evaluation Remarks

The bid total submitted by Airex Filter Corporation was corrected due to errors in math calculations.

Carrier Enterprise, LLC and Allure Hospitality Suppliers, Inc. were deemed non-responsive for failure to meet the minimum reference requirements. American Air Filter Company, Inc. DBA AAF International was deemed non-responsive for submitting an addendum which contains deviations from the County's contract terms and conditions. Aire Serv of Southeast Orlando and AramSCO, Inc., were deemed non-responsive for failure to submit a complete Reference Documentation Form with at least three references. Archer Key Solutions was deemed non-responsive for failure to submit a complete Reference Documentation Form with at least three references and for gross deficiencies as bidder failed to submit multiple required documents. Fastenal Company was deemed non-responsive for failure to submit a Bid Response Form and for gross deficiencies as bidder failed to submit multiple required documents. Bidder also submitted an offer based on a Sourcewell contract which contains terms conflicting with the County's contract terms and conditions, constituting a counteroffer. Filter King, LLC was deemed non-responsive for submitting a modification to our Bid Response Form by adding a line item for a delivery fee, constituting a counteroffer. Florence Filter Corporation was deemed non-responsive for adding an exception to our contract terms regarding warranty. The additional warranty terms conflict with the County's contract terms and conditions, constituting a counteroffer. Planet Holdings, Inc. was deemed non-responsive for failure to acknowledge Addendums 1 and 2. Addendum 2 contained material changes to the Invitation for Bids. Puremaxx, LLC was deemed non-responsive as bidder submitted two different bid response forms with different offers, therefore the County could not determine which bid is subject to evaluation.
