I. Call to Order

With a quorum present, Chair Gary Meloon called the meeting of the Lake Conway Water and Navigation Control District Advisory Board (Advisory Board) to order at 6:39 p.m.

II. Approval of the July 8, 2020 Meeting Minutes

Upon a motion by Bobby Lance, seconded by Francis Guthrie, and carried with all present members voting AYE by voice vote, with Micky Blackton being absent; the Advisory Board approved the July 8, 2020 meeting minutes.

III. Public Comment on Propositions before the Advisory Board

Chair Meloon received two public comment requests. City Manager Francis, City of Belle Isle (COBI), inquired if there are any corrective actions proposed for the water elevation of the Conway Chain. Ms. Urbanik will request for Jeff Charles, from Orange County Stormwater Division, to contact Mr. Francis. Randy Holihan, a resident on the south lobe, stated there was an overabundance of Illinois pondweed (*Potamogeton illinoensis*) within the navigable portion of the lake. Ms. Urbanik stated she will investigate.

V. Orange County EPD Report

Lake Gatlin Alum Treatment Proposal Update

Lake Conway Water and Navigation Control District Advisory Board Meeting Minutes August 11, 2020

Ms. Urbanik presented the scope of service to accomplish a future alum treatment. The Advisory Board requested striking through Task Numbers 1 and 8, and to request the completion timeframe to be modified to 45 days instead of 60 days. Ms. Urbanik will discuss those possibilities with Dr. Harvey Harper. Discussion ensued.

Upon a motion by Bobby Lance, seconded by Elizabeth Nelson, and carried with all present members voting AYE by voice vote, with Micky Blackton being absent; the Advisory Board approved the scope for the Lake Gatlin Water Quality Evaluation with the following options. Preference is requested for option A:

- A) Strike through Task Numbers 1 and 8 with a reduced project completion schedule to 45 days for a total cost of \$22,959.84.
- B) Strike through Task Number 8 for a total cost of \$23,466.18.
- C) Approved as is for a total cost of \$26,475.14.

Lake Conway Stormwater Study Update

Ms. Urbanik suggested holding a virtual meeting for the Lake Conway Stormwater Study community meeting. The Advisory Board concurred.

5 Year Budget Overview

Ms. Urbanik presented a 5 year budget snapshot.

VI. Marine Patrol Report

Ms. Urbanik presented the marine patrol report. For the month of July 2020, the following activities were reported:

- 17 vessel citations
- 35 vessel warnings
- 27 vessel inspections

Sergeant Millis reported they see an average of 50 vessels on a Saturday and Sunday. BIPD has received complaints of aggressive Personal Watercrafts (PWC) and boats at the sandbar area of Lake Conway at night.

VII. Lake Conway Water Elevation Report

David Woods presented his water elevation report. The Conway Chain of Lakes water level is currently at a higher elevation and is overflowing the weir. Mr. Woods asked when the boards at the outfall weir were removed and replaced. Ms. Urbanik stated she would send Mr. Woods the information.

VIII. Advisory Board Member Report

- Bobby Lance: Mr. Lance stated a dead triploid grass carp washed up on a resident's lakefront, and asked how many were last stocked in the lake. Ms. Urbanik stated in 2016, 2500 fish were stocked in the lake.
