#### A. Community Services

Mrs. Jackie Muse provided the committee with a brief overview of the Community Services Report, thru October 26, 2020. A copy of the Community Services Report was provided in the packet and at the meeting.

Mrs. Muse gave the board a brief update on the Goals and Outcomes for the 2020 Fiscal year (4/1/2020-3/31/2021): Unemployed and Obtained Job- Goal 100 - Achieved 8 (8%); Employed Participants Provided Increase in Income- Goal 35 - Achieved 5 (14%); Maintained Job 90 Days or More- Goal 40 - Achieved 5 (12%); Obtained Recognized Credential to Achieve Vocational Skills – Goal 100 - Achieved 35 (35%); Completed ABE/GED- Goal 5 - Achieved 0 (0%); Achieved and maintained capacity to meet basic needs- Achieved 908 (Utility Assistance).

Mrs. Muse expressed to the committee that Family Self-Sufficiency Program (FSSP) will be transitioning from assisting LIHEAP to FSSP Services in mid December,

# **B.** Strategic Plan
