A Motion to approve the nomination of Vivian Tindal as Treasurer of the Community Action Board, contingent upon her re-appointment for a third term and if she is not re-appointed Barbara Hoosier will be nominated as Treasurer, was made by Yesenia Baron and seconded by Sabrina Persaud. Motion passed and approved.
