Mrs. Catina Williams announced that there were several new appointments and re-appointments for today's meeting.

For the Public Sector: Mayor Jerry Demings office appoints Commissioner-Elect Nicole H. Wilson as representative, representing District 1; Mayor Deming's Office Re-appoints Commissioner Mayra Uribe as representative and Cortez Whatley as alternate, representing District 3; and Re-appoints Commissioner Maribel Gomez-Cordero as representative and Mariely Velez as alternate Representing District 4.

For the Community Sector: Eastwood Community Association recommends the appointment of Larry Glinzman as representative for At-Large Districts 3, 4, & 5.

For the Private Sector: Orange County Head Start recommends the appointment of Aquila Drayton as representative and Jessica Lovelady as alternate for the Orange County Head Start.

DIVISION MANAGER'S REPORT - Lavon Williams, Division Manager

Mrs. Lavon Williams recited the Community Action Promise. Mrs. Williams gave a brief update on the Community Action Services.

COMMUNITY CENTERS

Mrs. Lavon Williams announced to the board that although the centers are still technically closed, we have received approximately 7782 visits during the month of December 2020. The Community Centers are currently assisting citizens with registration for the COVID-19 vaccine thru the patient portal. One thousand six hundred seventy-three citizens were served by Community Action and Partners. Two thousand and eighty food boxes were distributed. Thirty-five citizens were provided hygiene related kits. Over 200 people volunteered at the Community Centers. Over 750 volunteer hours were provided at the Community Centers. West Orange Chamber of Commerce donated \$1,250 to Maxey Community Center to help 21 families with Christmas toys and food. Foundation for a Healthy West Orange donated 75 food vouchers for families in the Winter Garden, Pine Hills, and Apopka Communities.

LIHEAP

Mrs. Lavon Williams gave an update on the Low-Income Home Energy Assistance Program (LIHEAP) Direct Client Assistance Budget - \$6 million; Total Monthly expenditure YTD- \$696,787; total monthly units of service- 1,339; and average assistance per household - \$520; YTD Expenditures - \$5,326,709; YTD Units

of Service – 9,645; Average Assistance per Household - \$552. Mrs. Williams expressed to the board that although we were expecting to expend the CARES funding by September 2021 all of the those funds have been expended as of November 2020. applications for Home energy assistance is now online and available to the public Monday-Wednesday 8am- 12noon.

Senior Climate Efficiency Program

Mrs. Lavon Williams gave a brief update on the Senior Climate Efficiency Program (SCEP). SCEP serves low-income seniors by providing air conditioning/heat system repair and replacements. The program has completed system replacements on 27 homes since the beginning of January for the 2019-2020 fiscal year. The program has completed system replacements in 4 homes since the beginning of the 2020-2021 fiscal year. The program has received a grant from the Florida Department of Agriculture & Consumer Services for approximately \$100,000 to help the program do more servicing for citizens in need. The grant will go before the Board of County Commissioners on the January 26th, for final approval. We will be working with citizens that qualify for services on a case by case basis

Office on Aging

Mrs. Lavon Williams gave a brief overview of the Office on Aging Program Highlights. The update to the 40 page "Community Resource for Elders" document has been completed. The Commission on Aging Monthly E-Newsletter received 1,012 opens, 420 clicks. Five e-blast were sent out on the weekly issues. The LIFE Information for Elders December seminar on "Ask the Expert", had 5 attendees. Elder Ambassador Program continues to provide training services Elder Caregivers.

Community Services Block Grant (CSBG) Update

Mrs. Lavon Williams reported on the CSBG Quarterly Outcomes as of December 31st. Unemployed Adults that Obtained Employment- Goal 100 Achieved 13 (13%); Employed Participants that Provided Increase in Income - Goal 35 Achieved 7 (20%); Unemployed Adults that Maintained Employment 90 Days or More-Goal 40 Achieved 5 (13%); Obtained Recognized Credential to Achieve Vocational Skills- Goal 100 Achieved 42 (42%); and Completed High School Diploma or GED- Goal 5 Achieved 0 (0%); Achieved and Maintained Capacity to meet basic needs, Achieved 1420 (Utility Assistance). Mrs. Williams expressed that some of the outcomes take time to achieved, although the goal has not been completed progress is being made in working to complete certain goals such as the GED Program. Mrs. Williams also informed the board the we are currently working with the County Attorney's office to implement a wage subsidy program the will utilize the CARES Act funds that were received for the CSBG's Family Self Sufficiency Program. The program will encourage employers to hire our clients and offer a higher wage through the wage subsidy program. Mrs. Williams expressed to the board that the Family Self-Sufficiency Program (FSSP) program was directly hit by the COVID-19 pandemic due to the challenges with providing the needed services with schools being closed or only offering virtual services. We have received 400 referrals from the LIHEAP program alone, so these numbers will increase over time.

FINANCIAL REPORT

A copy of the Community Service Block Grant (CSBG) Budget Fiscal Year (FY) (April 1, 2020- March 31, 2021) as of January 5, 2021 was provided in the meeting packet.

Mrs. Lavon Williams gave a report of the CSBG Percentages of Budget Used: CSBG Program Services percentage used is 6%; CSBG Direct Client assistance percentage used is 12%; current CSBG total balance of \$492,033.39 YTD, with 32% of budget spent. The Cares Act Funds Current Budget is \$1,241,021.00, with 1% expended for CSBG Program Services. Mrs. Williams explained to the board that due to COVID-19, the FSSP Caseworkers have not done much case management, tuition reimbursement, and supportive services because they have been focusing on assisting with LIHEAP services. Due to the challenges with FSSP services the Department of Economic Opportunity has provide an extension to the Block Grant year so we will have until September 2021 to expend the CSBG funds.

Mr. Cortez Whatley asked what would be the qualifications for the FSSP Subsidy Program. Mrs. Lavon Williams informed the board that the qualifications for eligibility for the subsidy program with be aligned with the same qualifications as the regular FSSP Program. Mrs. Williams also expressed to the board that going forward the application process will be online as opposed to the previous in-person application process.

HEAD START POLICY COUNCIL REPORT

Ms. Aquila Drayton gave a brief introduction of herself and update on the Head Start Policy Council. Ms. Drayton expressed her gratitude for the opportunity to become a part of the Community Action Board. Orange County's Head Start staff is currently service children both face to face as well as virtually. The Orange County Head Start Program is currently recruiting 3 and 4year olds for the 20-21 school year. If anyone is interest please call the Head Start office at 407-836-6590. Ms. Drayton informed the board that Orange County Head Start are currently in the planning stages to roll out the Head Start Self-Assessment.
