ADDENDUM NO. 3 / IFB NO. Y17-743-RM
BARRY STREET DRAINAGE IMPROVEMENTS PROJECT

THE REVISED BID OPENING DATE IS APRIL 27, 2017

This Addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by underlining, deletions are indicated by ~~strikethrough~~.

A. THE BID OPENING DATE IS CHANGED FROM ~~April 25, 2017~~ to April 27, 2017

B. Revised Part C paragraph 28 of the IFB and Part D, Attachment E as follows:

REFERENCES:

Bidder should supply (with the bid form) a list of three (3) similar projects for drainage improvements including at least 300' of pipes, varying from at least 18"-30" in size as well as construction of inlets, curbs, gutter and asphalt resurfacing, successfully completed **by the Bidder, as a Prime or Sub Contractor** within the last eight (8) years. Failure to provide this information may be cause for rejection of the bid.

1. Bidder shall have installed a minimum of 300' of drainage pipe installation or replacement. This element can be demonstrated among several projects and is not required to all be in a single project.

2. Projects submitted should contain the following elements: These elements can be demonstrated among all projects and are not required to all be in a single project:

- a. Pipe installation using jack and bore method under a three to six lane roadway.
- b. Construction of Stormwater inlets, manholes, curb, gutter and asphalt resurfacing.
- c. Maintenance of traffic around state and local roads.
- d. Coordination with multiple government entities.

3. Must have been the prime contractor on at least two of the projects.

In addition to the similar projects elements listed, all Bidders are required to be currently pre-qualified with the Florida Department of Transportation (FDOT) in at least one of the following major classes of work required for this project. The documentation required to be submitted with the sealed bids shall include qualifying documentation from FDOT for the work types shown below:

The major classes of work are as follow:

Drainage
Flexible Paving
Hot Plant Mixed-Bitum Courses
Underground Utilities
Pavement Marking

Florida Law (Chapter 337.14 F.S.) And Rules of the State of Florida, Department of Transportation (Chapter 14-22, F.A.C.) require contractors to be prequalified with the Department in order to bid for the performance of road, bridge, or public transportation construction contracts greater than \$250,000.00.

Failure to submit proof of the FDOT pre-qualification for the major classes of work listed shall render the Bid non-responsive.

EACH SIMILAR PROJECT LISTED SHALL BE LISTED WITH COMPLETE INFORMATION AS SPECIFICALLY PROVIDED ON THE REFERENCE FORM (ATTACHMENT E). THE SPECIFIC INFORMATION ON REFERENCES MUST BE PROVIDED ON THE REFERENCE FORM. DO NOT ATTACH LISTINGS OF REFERENCE INFORMATION. FAILURE TO PROVIDE REFERENCE INFORMATION AS REQUESTED MAY RESULT IN THE REJECTION OF YOUR BID.

The determination of whether a bidder is responsible or not shall be at the sole discretion of the County. Although the County may request submission of a minimum number of similar projects for evaluation, the County's determination of a bidder's responsibility shall not be solely based on the number of similar projects submitted.

The contact person listed as a reference shall be someone who has personal knowledge of the Bidder's performance during the referenced project. Contact persons must have been informed that they are being used as a reference and that the County will be calling or emailing them.

C. All other terms, conditions and specifications remain the same.

The Bidder shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of the bid.
