CABINETS & CONTROLS REPLACEMENT

Proposal Due Date August 28, 2018

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. The Proposal Due Date remains as August 28, 2018.

B. The following are questions/responses/clarifications:

Question 1: Under similar projects is it possible to reduce the square feet to following:

- Reduce building square footage to 300,000 SF.
- Reduce project type A to 100,000 SF.
- Reduce project type B to 60,000 SF.
- Allow color changing LED to be for interior OR exterior

Response 1: See updated Similar Projects below:

“Similar Projects” for the proposed Project Manager (Architect or Engineer) and the proposed Project Engineer (Professional Engineer) for the purpose of this Request for Proposals (RFP) has been defined as a single project (if a phased project all phases shall be successfully completed), as successfully completed project within the last 20 years within the contiguous United States, Alaska, and Hawaii that included professional Design Services for the renovation or expansion in a building space of at least ~~750,000~~ 300,000 contiguous square feet that is in an ACTIVE, fully operational, general assembly (airports, arenas, convention centers, educational facilities, hospitals, hotels or stadiums). If a “Similar Project” is a phased project, all phases shall be substantially completed. The “Similar Projects” shall have included the following:

1. Renovation, upgrade or expansion of commercial lighting control system managing at least three (3) lighting control systems which have the capability to schedule the point of service LED lighting with on/off and dimming capability;
2. Project Type A: One (1) project shall have occurred within a general assembly facility with a minimum gross Project size of ~~300,000~~ 150,000 contiguous square feet

3. Project Type B: Two (2) other separate projects shall have occurred within a general assembly facility with a minimum gross Project size of ~~100,000~~ 60,000 contiguous square feet each; and
4. At least one (1) project shall include the control of an interior or exterior Color LED system with automation or scheduling of que list or shows.
5. At least one (1) project shall include the upgrade of a commercial lighting system installed and commissioned while the existing lighting system remained active and servicing the facility normal business operations.
6. At least one (1) project shall include lighting system within a 30,000 square foot ballroom.

C. All other terms and conditions of the RFP remain the same.

D. The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of the proposal.
