

**REQUEST FOR QUALIFICATIONS

The Orange County Board of County Commissioners, Orange County, Florida, is soliciting for sealed qualifications in an **original and Three (3) copies** for providing exterior landscape management services for the Parks and Recreation Division. This is a 2-step procurement process. Step 1 is comprised of this Request for Qualifications. Step 2 shall be an Invitation for Bids, as needs arise, only among those firms pre-qualified in Step 1. The list of Pre-Qualified firms resulting from this RFQ shall be valid for a three (3) year period.

Qualifications will be accepted up to 2:00 P.M., Thursday, March 14, 2019 (local time), in the Purchasing and Contracts Division, Internal Operations Centre II, 400 E. South Street, 2nd Floor, Orlando, FL 32801.

Submittals shall be mailed or hand delivered in a sealed envelope to the above address. Indicate the following on the sealed envelope:

General turf maintenance includes property at County Parks at mow heights of 4", excluding sports turf.

REQUEST FOR QUALIFICATIONS EXTERIOR LANDSCAPE MAINTENANCE GENERAL TURF MAINTENANCE

The Orange County Board of County Commissioners, Orange County, Florida, is soliciting for sealed qualifications for providing exterior landscape management services for **GENERAL LANDSCAPE MAINTENANCE** at County Parks. The selection of pre-qualified firms shall not restrict the County from requiring additional minimum qualifications as the County deems necessary in the Invitations for Bids for any specific project.

Vendors shall submit the following:

1. EXPERIENCE

Experience record showing the firm's experience in landscape management to include mowing, edging, trimming, blowing, fertilization, pest control, flowers, ground cover, trees, mulch, trash removal / disposal, and irrigation

- a. Provide an affirmative statement declaring the firm being submitted for pre-qualification has a minimum of five (5) consecutive years experience in general turf maintenance in the commercial or governmental exterior landscape industry under the current company name.
- b. Submit a copy of your current occupational license.
- c. List three (3) distinct, current, commercial or government agency references.
- d. List the firm's principal ownership and current general manager of the firm.
- e. Indicate how long your firm has been in business under its current name.

2. INSURANCE

- a. Provide a letter or an Accord Form from an authorized Insurance Agent or Insurance Company(s) certifying that your firm has or can obtain a Certificate of Insurance within ten (10) calendar of any contract award for the following required insurance:

Insurance carriers providing coverage required herein must be licensed to conduct business in the State of Florida and must possess a current A.M. Best's Financial Strength Rating of A- Class VIII or better.

Vendor/Contractor further agrees coverage shall not contain any endorsement(s) excluding or limiting Product/Completed Operations, Contractual Liability, or Separation of Insureds. The General Aggregate limit shall either apply separately to this contract or shall be at least twice the required occurrence limit.

Note: CG 20 10 must be accompanied by CG 20 37 to include products/completed operations
- Waiver of Transfer of Rights of Recovery- CG 24 04 or its equivalent.
Note: If blanket endorsements are being submitted please include the entire endorsement and the applicable policy number.

- Business Automobile Liability - The Vendor/Contractor shall maintain coverage for all owned; non-owned and hired vehicles issued on the most recent version of the ISO form as filed for use in Florida or its equivalent, with limits of not less than \$1,000,000 per accident. In the event the Vendor/Contractor does not own automobiles the Vendor/Contractor shall maintain coverage for hired and non-owned auto liability, which may be satisfied by way of endorsement to the Commercial General Liability policy or separate Business Auto Liability policy.

- Workers' Compensation - The Vendor/Contractor shall maintain coverage for its employees with statutory workers' compensation limits, and no less than \$1,000,000 each incident of bodily injury or disease for Employers' Liability. - d. Provide fertilize licensure and picture of decal on company truck with truck number/license plate. The Contractor shall comply with all sections of Chapter 482.1562, Florida Statutes and Orange County Ordinance Code 15 Article XVII regarding fertilization services including proper licensure and decal on company vehicle whether by the Contractor or a sub-contractor that shall be listed on the schedule of subcontracting form provided herein.
- e. Provide the name and a copy of the current qualified (Florida Irrigation Society licensed preferred) or Irrigation Certification of irrigation technician capable of repairing and adjusting irrigation systems
- f. Provide a statement confirming that one Company representative at each work site shall be fluent in the English language.
- g. Provide a statement confirming that all employees assigned to work on any contract for the County are legal US citizens or possess proof of eligibility from the United States Immigration and Naturalization Service to be employed in the United States.

4. EQUIPMENT

- b. Submit the firm's equipment maintenance schedule to include maintenance locations. Equipment shall be maintained to meet OSHA and manufacturer requirements and be able to perform the job in a safe and professional manner.

The Orange County Board of County Commissioners, Orange County, Florida, is soliciting for sealed qualifications for providing mowing services for **Sport Turf** of Bermuda 419. The selection of pre-qualified firms shall not restrict the County from requiring additional minimum qualifications as the County deems necessary in the Invitations for Bids for any specific project. Sports turf maintenance includes property at County Parks.

Vendors shall submit the following:

1. EXPERIENCE

Experience record showing the firm's training and experience in sports turf mowing as it relates to each selected category. Turf mowing includes, but may not be limited to, mowing, edging, trimming, blowing, fertilization, pest control, and irrigation. **Qualifications will only be considered from contractors that are regularly engaged in sports turf mowing services and cultural practices of Bermuda Turf Athletic Fields.**

- a. Provide an affirmative statement declaring the firm being submitted for pre-qualification has a minimum of five (5) consecutive years providing sports turf maintenance for commercial or governmental properties under the current company name.
- b. List a minimum of three (3) distinct current commercial or government agency references for sports turf maintenance and provide a brief description of the work, location, dates of contract, names, addresses and telephone number of client contact. If less than three references are current, such references may be from recent clients whose expired within the past 12 months.
