ADDENDUM NO. 1 / IFB NO. Y17-1107-RM COUNTYWIDE RESTORATION OF SHOULDERS AND DITCHES

Bid Opening Date: June 20, 2017

This Addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by <u>underlining</u>, deletions are indicated by <u>strikethrough</u>.

A. The Bid Opening Date remains June 20, 2017.

B. The following are responses to bidder's inquiries.

1. Scope of work states that there will be culvert replacement in this contract but there is no line item for this work. Will culverts be required for this contract term and if so, can you provide pipe type and sizes as a line item.

Response: Culvert replacement is not included in this contract.

2. Line item for message boards - is this item for each day the boards are installed on site or is this work for additional time after the normal 10 day required time frame? In other words in our base rate per SY are we including 10 days for two message boards and then if Orange County wants more than 10 days is this line item rate being added per board per day or are we not to include any message boards in our base rates?

Response: Message Board cost for item 10, 20, 29 is for additional days or additional boards at the County's request. Unit pricing for the SY should include all MOT, labor, material, equipment etc.

3. Some projects will require excess material/sod/strippings to be hauled offsite while others will not. This haul off has caused us to actually lose money on the smaller projects requiring hauling off of considerable material/sod/strippings. There is no line item for removal of excess materials/sod/strippings from the site area. Are we to figure that all projects will be a worst case scenario and require haul off?

Response: Unit pricing shall include removal of excess material as stated in the item descriptions.

C. <u>CHANGES TO SPECIFICATIONS:</u>

This addendum includes clarifications, corrections, additions, deletions, and revisions that take precedence over the original bid documents. Below is a list of the information contained herein.

Regarding Part D, Pages D-3 through D-4; DELETE existing "Bid Item Schedule" and REPLACE with the attached "Revised Bid Item Schedule" pages D-3 through D-4.
