#### **Questions and Answers**

**Question 1:** Scope of Services: Section 1.4 Does the County want the contractor to be licensed in the category of Right of Way by the Florida Department of Agriculture and Consumer Services?

**Answer:** Yes, Contractors shall be licensed in the category of Right of ways for herbicides.

**Question 2**: Are we supposed to inspect the sites every month or just two times a year? See below for confusion. If we are to inspect every month how will we charge for that? How often are we supposed to service these sites? If we inspect and service just two times a year what months do we service?

Answer: Contractors shall perform Monthly inspections to ensure that sites are weed free and shall be included in the vendors bid pricing. Sites shall be treated/serviced two (2) times per year. Any re-treatment needed between each treatment cycle shall be provided by the Contractor at no cost to the County. Section 3. Scope of Services, 3. TECHNICAL REQUIREMENTS AND SCHEDULING SERVICES, 3.5 Service Schedule outlines the parameters and timeline months for treatments and inspections.

**Question 3:** Can you please provide the locations of the pump? **Answer:** Yes, locations for pumps can be found on the (REVISED) Bid Response Form – IFB Y19-1042-TJ.
