  - A. Proposers must address how they intend to comply with the Orange County M/WBE Ordinance, No. 94-02 and amended by Ordinance N. 2009-21. The goal of certified minority/women business enterprise is 24% of the contract value for this project. The Ordinance also addresses minority/women group employment levels setting goals to encourage each Proposer to maintain 24% 18% minority and 6% women employee workforce levels in specific categories.

## C. QUESTIONS & ANSWERS:

**1. Question:** Can you please inform me of the contract period of performance? I cannot identify the contract length which the consultant should be prepared to perform the scope.

**Answer:** Per Provision No. 3, Contract Term, under the General Terms and Conditions of this RFP, it is the intent of the County to enter into a three (3) year term contract, with renewal clause for two (2) additional one (1) year terms.

**2. Question:** RFP Page 3, Tab 2. For the five required references, must all references relate directly to CUP work, or might we also submit references from larger monitoring programs experience with State and Federal agencies?

**Answer:** It is to the Proposer's discretion to determine what references to provide which meet the requirements established in the RFP.
