- B. **The Questions due date is hereby changed to 5:00PM to Wednesday, August 28, 2019 to the attention of Ana Villalona, Procurement Division, [Ana.Villalona@ocfl.net](mailto:Ana.Villalona@ocfl.net).**
  
- C. **Non-mandatory site visit will be held on Friday, August 23, 2019, to meet at 10:00AM, at the Orange County Landfill Lobby – 5901 Young Pine Road, Orlando, FL 32829. Attendance is not mandatory but is encouraged.**
  
- D. **Questions and Answers**
  - 1. **Question:** Is there a Pre-Bid meeting? If there is not, is the site available for inspection prior to bidding at any point?  
**Answer:** A site meeting has been scheduled in this Addendum 1, section C, for Friday, August, 23, 2019.
  
  - 2. **Question:** Does the County have a material log of inbound yard waste by month for the last 3-5 years?  
**Answer:** A Landfill Yard Waste Tonnage by Month 2014-2019 has been added to this Addendum 1, as Attachment 1.
  
  - 3. **Question:** Does the County have details about the construction of the pad, such as permit applications, engineer drawings, etc...?  
**Answer:** Yes. The yard waste is currently located on an asphalt-paved pad and it is permitted under the Class I Operations Permit 0128169-046-SO-MM.

4. **Question:** Where is the material being trucked to? It is always on County owned property?  
**Answer:** The material is delivered to a designated area on site. Yes, it is on County owned property.
  
5. **Question:** What method is used to determine volumes?  
**Answer:** Measurement of the work will be by the volume of mulched product produced. See Scope of services, paragraph 6. Measurement and Payment.
  
6. **Question:** Should we supply a methodology in our proposal as Contractors?  
**Answer:** No. This is an Invitation For Bid and a methodology is not required.
  
7. **Question:** Does the County supply a spotter to monitor contamination of the yard waste?  
**Answer:** Yes, a County spotter is present at the facility to identify and direct the correct disposal of yard waste at the site. See Scope of Services, paragraph 2.
  
8. **Question:** What is the previous years' contract?
