- B. Section 3 Specifications/Scope of Services, E. Shipping is modified as follows:
  - a. Cots, accessories, rolling racks and dust covers <u>must be shipped as complete units</u> or palletized if items are shipped as individual items.
  - b. Pallets or complete units must be balanced and contents secured and protected
  - c. Offloaded onto loading dock by Contractor's shipping agency or Contractor's staff
  - d. Deliver to 101 Suddath Dr., Orlando, FL 32806 between the hours of 8am and 5pm, Monday Friday.
  - e. Call phone number on Purchase Order for delivery coordination

## C. Questions and Answers

- 1. Question: If awarded, may we ship without pallets to minimize dunnage and additional shipping costs? Supporting Statement: The quantity specified indicates three full truck loads of equipment which means they will not need to be palletized. This equipment will be secured and insured to protect the Clients best interest. The Carts have Casters and all additional equipment is loaded in the carts for simplified delivery/deployment. Ref: Under Specification / Scope and Services: Section E: Shipping; a. Cots, accessories, rolling racks, and dust covers palletized.
  - a. <u>Answer:</u> Yes. Cots, accessories, rolling racks and dust covers <u>must be shipped</u> as complete units or palletized if items are shipped as individual items.
- 2. Question: Can the Receiver offload the truck themselves? Supporting Statement: I have verified with my logistical department that Common Carriers are not able to offload equipment for End Users. If this is a requirement for the award I will make arrangements to send personnel down to offload equipment under directions of the Contracting Agency and I will provide the proper Insurance Certificates described under the IFB. Ref: Under Specification / Scope and Services: Section E: Shipping; c. Offloaded onto loading dock by Contractors shipping agency staff

<u>Answer</u>: No. Items must be offloaded onto the loading dock by the shipping agency or Contractor's staff.
