This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. A. The Bid Opening Date has changed as follows:

B. The following are Requests for Information received and their responses:

1. **Question:** Will the Subcontractor prequalification meet or satisfy the FDOT requirement?

Response: The pre-qualifications shall be held by the Prime contractor.

2. **Question:** There are other pre-qualification classes required in the work as drainage, sidewalk (horizontal concrete any type). Will these pre-qualification classes be also accepted and valid to qualify?

Response: DRAINAGE has been added to the list as an acceptable prequalification work class, see revised C-12 and revised Attachment E attached in this Addendum.

C. Note the REVISION to Form S, Affidavit of Compliance WITH 2 CFR 200.321 Requirements as follows:

Similar Projects

Bidder shall submit projects that show previous successful project experience with the following elements for a total of three (3) examples for each element. All elements are not required to be in the same project.

In addition to the above similar project elements, all Bidders are required to be currently pre-qualified with the Florida Department of Transportation (FDOT) in at least two of the following major classes of work required for this project, one of which must be FLEXIBLE PAVING. The documentation is required to be submitted with the sealed Bids and shall include qualifying documentation from FDOT for the work types shown below:

- FENCING
- FLEXIBLE PAVING
- GRADING
- GRASSING, SEEDING AND SODDING
- HOT PLANT MIXED-BITUM COURSES
- PORTLAND CEMENT
- PAVEMENT MARKING
- Drainage

Florida Law (Chapter 337.14 F.S.) And Rules of the State of Florida, Department of Transportation, (Chapter 14-22, F.A.C.) require contractors to be prequalified with the Department in order to bid for the performance of road, bridge, or public transportation construction contracts greater than \$250,000.00.

Failure to submit proof of the FDOT pre-qualification for the major classes of work listed in Paragraph 31 shall render the Bid non-responsive.

Similar Projects

Bidder shall submit projects that show previous successful project experience with the following elements for a total of three (3) examples for each element. All elements are not required to be in the same project.

Project Elements

1. Construction of an urban roadway intersection having a minimum length of 0.25 miles and a roadway construction cost, which excludes any utility work, equal to or greater than two hundred thousand dollars (\$200,000). For purposes of this Invitation for Bid, "urban" is defined as projects which traverse an urbanized area which may have multiple intersecting streets and connecting driveways.
2. Preparation of roadway as-builts.
3. Construction of roadway stormwater conveyance system (must include at least 100 feet of 18" or larger pipe installation).
4. Coordination with utility companies.

FAILURE TO PROVIDE REFERENCE INFORMATION AS REQUESTED MAY RESULT IN THE REJECTION OF YOUR BID.

In addition to the above similar project elements, all Bidders are required to be currently pre-qualified with the Florida Department of Transportation (FDOT) in at least two of the following major classes of work required for this project, one of which must be FLEXIBLE PAVING.
