 - 1. Question: I wanted to clarify if we could bid the project as a prime since we do not have an established office in the Orlando MSA area, I did see the local preference statement but just making sure?
 Answer: Yes, your firm can bid the project as a prime. Having an established office in the Orlando MSA area is only one of the certification criteria's. All participating M/WBE's must be certified by Orange County. Therefore, your Vero Beach M/WBE certification cannot be used for this solicitation.
 - 2. Question: If so, our MWBE goals would be met as required in the bid documents through the certified directory to find subcontractors?
 Answer: Our Business Development M/WBE Directory is available by e-mail or through the Orange County web site at Orangecountyfl.net. All firms must be certified prior to bid opening and must be certified in the area(s) for which they will be used
 - 3. Question: Also, would any percentage of self-performed work by our firm count towards the MWBE participation goal?
 Answer: No. M/WBE Bidders competing as primes (Section 3, paragraph c of the Instructions To Bidder) is only applicable to certified Orange County M/WBEs.
 - **4. Question:** Would we need to register with Orange County prior to bidding? **Answer:** If you plan to bid as a certified Orange County M/WBE. The certification processing timeframe is 60-business days from the date our office receives your application.
 - **5. Question:** As a MWBE Prime Contractor, are we required to turn in form C-3?

Answer: No. The form C-3 is called the Letter of Intent form. This form is required to be turned in for all Orange County certified M/WBE subcontractors listed in the prime contractor's bid submitted to Orange County Procurement.
