DESIGN SERVICES FOR ORANGE COUNTY CONVENTION CENTER
CAMPUS ROADWAY AND PARKING IMPROVEMENTS

Bid Opening Date: February 26, 2019

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. The Bid Opening Date remains as February 26, 2019.

B. The following are questions/responses/clarifications:

1. Please confirm that the Scope is limited to roadway resurfacing from back of curb to back of curb and does not involve roadway reconstruction (i.e., drainage, sidewalk, landscaping, etc.).

Response: The majority of this project is resurfacing. However, if it is determined that the existing base/subgrade or drainage system is insufficient or compromised then reconstruction will be required.

2. Please confirm if Landscape Architecture should be accounted for in the Scope.

Response: Landscaping is not included in this scope of work.

3. Has the existing drainage in the parking lots and roadways been reviewed/analyzed/checked (i.e., adequate number of drainage inlets, etc.)?

Response: The existing drainage has not been reviewed or analyzed. It is our expectation for this to be included in the design services.

4. At the Pre-Proposal meeting, the County announced that they would be scheduling a site walk through and that the date of that site walk through would be issued as an Addendum. When is the site walk through scheduled for/when can the Addendum be expected to be released?

Response: A Site walkthrough will be held Friday 2/22/19 at 1:30 pm.

5. The Construction Administration portion of the Scope appears to be both Construction Management and Construction Engineering & Inspection (CEI) Services. Please confirm whether or not this is the case.

Response: It is expected the consultant will assist the OCCC PM during the construction phase of the project with the task listed in the RFP. The consultant is not expected to manage the project through construction.

6. What is the expected construction budget for this project?

Response: Budget Information will be provided to the successful Bidder.

7. Will the County accept Similar Projects with a minimum length of <1,000 feet?

Response: No, OC will not accept a minimum length of <1,000 feet.. Refer to RFP #19-808-JS, Page #13, Item 26. "SIMILAR PROJECTS", a). "..... Minimum length of 1,000 feet."

8. Are the RFP Forms available in editable PDF or Word Document format?

9. Specifications According to Form F, an Organization Chart should be included as "Form F-4." Is this in violation of, or an exception to, "Instructions to Proposers" Item 7?

Response: No it is not a violation. The Proposers shall comply with Form F, to provide an organizational chart for the team.

C. All other term and conditions of the IFB remain the same.

D. The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum.
