FERAL HOG CAPTURE AND REMOVAL SERVICES FOR ORANGE COUNTY

This Addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions, and/or revisions to and shall take precedence over the original documents. Additions are indicated by **underlining** and deletions via ~~strikethrough~~.

- A. The Bid Opening Date remains Tuesday, September 10, 2019 at 2:00PM.**
- B. Section 4, Bid Submission Requirement and Documentation, Bid Response Form IFB #20-105-SW, is replaced in its entirety with the attached Revised Bid Response Form IFB #Y20-105-SW.**
- C. Questions and Answers:**
1. **Question:** How many hogs were captured/removed in the previous contract?
Answer: During the previous contract, over a three year period, over 300 hogs were captured and removed.
 2. **Question:** Why is "Pollution Liability" necessary?
Answer: In the event, fueling of ATV's or mules will be conducted onsite.
 3. **Question:** Can there be a line item added for the monthly reporting as in the last contract?
Answer: Yes. Refer to the attached Revised Bid Response Form.
 4. **Question:** What does "Feral hogs that are not to be removed from the property shall be disposed of by the Contractor at the direction of the Division Project Manager" mean? (buried/left??).
Answer: Due to the Risk position that guns not be used on the properties the contractor should anticipate removing all hogs from the site. If in the event a hog died in the cage the carcass would need to be buried.
 5. **Question:** Will we bill per DO?
Answer: Based on the last contract, one DO was issued for the year that accounted for all of the monthly surveys since that contractor chose not to charge per hog removed. It is anticipated that we would issue one DO annually

and the contractor would submit a monthly invoice. EPD is flexible and will work with the selected contractor to set up a system that works with their companies accounting practices so long as it is consistent with the County's requirements.

6. **Question:** Is there a chance to extend the date of this rebid?

Answer: Refer to Addendum No. 2.
