**SOUTH WATER RECLAMATION FACILITY PHASE 6A IMPROVEMENT**

**RFP OPENING DATE: August 27, 2019**

This Addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents.

**A. QUESTIONS AND ANSWERS:**

- 1. QUESTION:** Is it possible to change the Similar Project Type B to:

*Project Type B: A project including the construction of a diesel-engine driven generators, each with a minimum design capacity of 2,000 KW including 1,200 Amp, 480 Volt paralleling switchgear with open or closed transition transfer between generators and the power utility.*

If this is not possible, is it possible to change item g to:

*g. The proposed Project Manager shall submit three similar projects (Type A, B or C) including at least one (1) Project Type A and one (1) Project Type C. The proposed Project Engineer(s) must submit only one(1) Project Type A, one (1) Project Type B, and one (1) Project Type C.*

**RESPONSE:** There will be no change.

- 2. QUESTION:** Project Type A: Can firm pumping capacity be 6 MGD or total pumping capacity be 10 MGD

**RESPONSE:** There will be no change.

- 3. QUESTION:** Related to Paragraph 26, Similar Projects, specific to subparagraph g. (page 15):

Can the same project be used to fulfill more than one Project Type A, B, or C? Said another way, if I have one project with distinct elements that meet both the Type A and Type B criteria, can I use that one project for both type A and Type B?

**RESPONSE:** The same project may be submitted for both Type A and Type B Projects, as long as it meets all other requirements.

**4. QUESTION:** Is there a required goal for the minimum percentage of the work assigned to the subconsultants, as reflected on Form C, that we must meet in order to obtain full points for Location?

**RESPONSE:** There is not a minimum percentage of the work that needs to be assigned to the subconsultants that the Consultant must meet in order to obtain full points for Location.

- B.** a. The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of proposal.
- b. All other terms, conditions and specifications remain the same.
